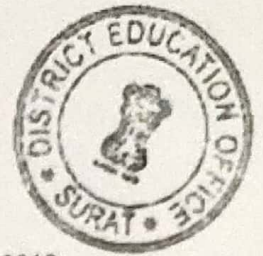

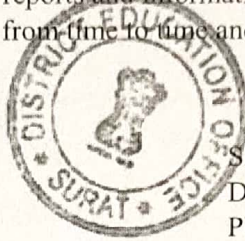

Subject to the provisions of the Gujarat Right of Children to Free and Compulsory Education Rules, 2011 made under the Right of Children Free and Compulsory Education ACT, 2009 the certificate of recognition is hereby grant to the manager the **Radiant English Academy** managed by **Vidyonnati Education Trust, Piplod, Surat Gujarat** (hereinafter called "the certificate") for Class I to Class 8 for a period of three years w.e.f 2019 to 2022 on the following conditions. namely:

CONDITIONS

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
2. The School shall be abide by the provisions of Right of Children to Free and Compulsory Education Act. 2009 (35 of 2009), the Gujarat Right of Children to Free and Compulsory Education Rules. 2011, the guidelines issued by the Government of India and the State Government and any instructions, directions or Government Resolutions.
3. The School shall admit in class I, including pre-primary classes, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion.
4. Taking capitation fee is prohibited and therefore the trust Society or School shall not collect any capitation fee or in any way other donations or articles in lieu of such fees.
5. The school shall not adopt in any way any screening test or procedure of the child or his or her parents or guardians for the purposes of admission.
6. The School shall not deny admission to any child for lack of age proof or on the ground of religion, caste. creed or race. place of birth or any of them.
7. The School shall ensure that:
 - i. No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
 - ii. No child shall be subjected to physical punishment or mental harassment;
 - iii. No child is required to pass any board examination till the completion of elementary education;
 - iv. Every child completing elementary education shall be awarded a certificate as laid down under Rule 30
 - v. The Students with disabilities or special needs are admitted/included as per provision of the Act. (a) the teachers are recruited having and fulfilling the minimum qualifications as laid by National Council of Teachers Education and State Government or the such authority authorized under sub-section (I) of section 23 of the Act.
8. No unrecognized classes shall be run within the premises of the school or outside in the same name of school.
9. The school buildings or other structures or the grounds are used only for the purpose's education and skill development.
10. The School is run by a society registered under the Societies Registration Act. 1860 (21 of 1860), or a public trust constituted under any law for the time being in force.

11. The School is not run for profit to any individual, group or association of individuals or any other persons; The accounts shall be audited and certified by a Chartered Accountant and proper accounts statements shall be prepared as per rules.
12. A copy of the audited report with all Statements of Accounts shall be sent to the Competent Authority every year. The recognition Code Number allotted to your school is 3677119 This may please be noted and quoted for any correspondence with this office.
13. The school shall furnish such reports and information as may be required by the Director and the Competent Authority from time to time and complies with such instructions of the State Government.
